Please Note:

- Items that may cause harm to persons or property, such as stink bombs, silly string, poppers, marshmallow guns, colored hair spray, candy/fake cigarettes, and weapons of any type **will not** be tolerated!!! If found with these items, you will first be asked to put them away, second time you will be asked to leave the Festival, no refund of registration fees, and you **will not** be permitted to return to the Festival in future years.)
- All **Food Vendors** must post prices of all items being sold

General Information:

- Remove all trash from your booth location. Do not dump liquids on the ground or leave any liquids for trash pick-up. Large dumpsters will be available.
- The City of Hoschton and the Hoschton Fall Festival Committee will not ensure that electrical power will be available at any or all booth locations. So please plan accordingly. If you use a portable generator, it must be a quiet model and not disrupt neighboring booths.
- Vendors cannot have vehicles in booth areas except during times for loading or unloading materials. Vendors will be provided an access card to be display in vehicle.
- Only vehicles allowed in booth areas during operating times of the festival will display a special Fall Festival volunteer/staff sign or emergency vehicles.

Use of Official Logo:

If you wish to use the official logo, you may purchase that right by contacting the Hoschton Fall Festival Committee. The cost is \$100 for non-Hoschton Business Alliance members and \$50.00 for Hoschton Business Alliance members. The license will be good for two years—until April 1, 2011.
